Robert V. Andelson (Ph.D., University of Southern California), professor of philosophy and a member of the Graduate School faculty at Auburn University, is author of Imputed Rights: An Essay in Christian Social Theory (1971), editor and co-author of Critics of Henry George (1979), and joint-author (with J. M. Dawsey) of From Wasteland to Promised Land: Liberation Theology for a Post-Marxist World (in press). An ordained Congregationalist minister, his articles in ethics and social philosophy have appeared in scholarly periodicals over several decades. He served on the editorial board of The Personalist for the last five years of its existence, and continues to serve on that of The American Journal of Economics and Sociology.

Roy Douglas (Ph.D., University of Edinburgh), reader emeritus in the department of general studies, University of Surrey, began his professional career in the field of biology, but his books have made him a recognized authority on modern political history. They include Law for Technologists (1964), The History of the British Liberal Party, 1895-1970 (1971), Land, People and Politics: The Land Question in the United Kingdom, 1878-1952 (1976), In the Year of Munich (1977), The Advent of War, 1939-40 (1978), From War to Cold War, 1942-48 (1981), New Alliances, 1940-41 (1982), World Crisis and British Decline, 1929-56 (1986), and World War, 1939-45: The Cartoonists' Vision (1990). He is also author of a number of articles, essays, and book chapters on historical, philosophical and scientific subjects, and editor of 1939: A Retrospect Forty Years After (1983). Dr. Douglas is, in addition, a barrister, and was on five occasions a Liberal candidate for Parliament.

Alexandra R. Hardie (Ph.D., University of Exeter), lecturer in

economics at Exeter, is author of seven articles and book chapters, and co-author of two articles on economic policy.

Garrett Hardin (Ph.D., Stanford University), professor emeritus of human ecology, University of California at Santa Barbara, is generally recognized as one of the seminal thinkers of our time. His books include Nature and Man's Fate (1959), Exploring New Ethics for Survival (1972), Naked Emperors: Essays of a Taboo-Stalker (1982), and Filters Against Folly: How to Survive Despite Economists, Ecologists, and the Merely Eloquent (1985). His most widely-reprinted articles are 'The Tragedy of the Commons' (1968) and 'Living on a Lifeboat' (1974).

Fred Harrison (B.A., Oxford University; M.Sc., University of London), founder and director of the Centre for Incentive Taxation, was for more than twenty years an investigative reporter for well-known London weeklies. He is author of *The Power in the Land* (1983), *Brady and Hindley: The Genesis of the Moors Murders* (1986), of chapters in three other books, and of monographs and articles on subjects ranging from politics to environmental and urban issues. Since 1978 he has served as editor of the international bi-monthly journal, *Land and Liberty*.

David Richards (M.A., Oxford University), was from 1983 to 1985 convenor of the Land Policy Working Group of the United Kingdom Green Party. He is senior researcher with the Economics and Social Science Research Association, London. He supervised a major portion of the research for Costing the Earth (1989), to which he contributed a chapter, as he also has to other books.

T. Nicolaus Tideman (Ph.D., University of Chicago), professor of economics at Virginia Polytechnic Institute and State University, has been a research associate at the Kennedy School of Government, Harvard University; a member of the senior staff of the President's Council of Economic Advisers; and a member of the economics faculty at Harvard. He is editor or co-editor of two books, sole author of 28 and co-author of 21 journal articles and book chapters — all in economics, public choice, and related areas.
