ROBERT V. ANDELSON (Ph.D., University of Southern California) is professor of philosophy and a member of the graduate faculty at Auburn University. Current and past president of the Alabama Philosophical Society, his publications include *Imputed Rights* (University of Georgia Press) and numerous articles in ethics and social philosophy. He serves on the editorial boards of *The Personalist* and *The American Journal of Economics and Sociology*. His interest in the thought of Henry George extends over a period of more than thirty years.

GEORGE BABILOT (Ph.D., University of Oregon), professor of economics and director of the Center for Public Economics, San Diego State University, is author of monographs, essays, and articles on taxation, public finance, and welfare economics.

JAMES L. BUSEY (Ph.D., Ohio State University), professor and chairman of the department of political science, Cragmore Campus, University of Colorado, has many books and articles to his credit, including *Latin America: Political Institutions and Processes* (Random House), *Notes on Costa Rican Democracy* (University of Colorado Press) and *Political Aspects of the Panama Canal* (University of Arizona Press).

CHARLES F. COLLIER (Ph.D., Duke University) is assistant professor of economics at Hamilton College, Clinton, N.Y. He has previously published an article in the history of economic thought.

STEVEN B. CORD (Ed.D., Columbia University), professor of history, Indiana University of Pennsylvania, is author of *Henry George: Dreamer or Realist?* (University of Pennsylvania Press) and numerous articles. He serves as president of the Henry George Foundation of America.

ROY DOUGLAS (Ph.D., University of Edinburgh), senior lecturer in the department of general studies, University of Surrey, began his professional career in the field of biology, but his books have made him a recognized authority on modern political history. They include *The History of the British Liberal Party, 1895-1970* (Fairleigh Dickinson University Press), *Land, People and Politics* (St. Martin's Press), *In the Year of Munich* (Macmillan) and *The Advent of War, 1939-40* (Macmillan). He is also a barrister.

AARON B. FULLER (Ph.D., University of Virginia), formerly served as an assistant professor of economics in the California State University system, and since 1975 has been an economist on the staff of the Institute for Defense

Analyses, Arlington, Virginia. He is author of various articles and papers in the history of economic thought, and of monographs related to the economics of national defense.

MASON GAFFNEY (Ph.D., University of California at Berkeley) is currently professor of economics at the Graduate School of Administration, University of California at Riverside. His previous positions include executive director, British Columbia Institute for Economic Policy Analysis; senior research associate, Resources for the Future; professor and chairman, department of economics, University of Wisconsin at Milwaukee; and professor of agricultural economics, University of Missouri. A director of the Western Tax Association, he is the author of *Containment Policies for Urban Sprawl* (University of Kansas Press) as well as numerous monographs, chapters, and articles on taxation and land use, and editor of *Extractive Resources and Taxation* (University of Wisconsin Press).

FRED HARRISON (A.B., Oxford University; M.Sc., University of London) is an investigative reporter for the London *Sunday People*. He also finds time to edit *Land and Liberty* and (in emergencies) the British Liberal Party *News*, and to write monographs and articles in economics and social theory. His book on the distortion of the laissez faire economy by land monopoly should be nearing completion as this goes to press.

C. LOWELL HARRISS (Ph.D., Columbia University), professor of economics at Columbia, serves as consultant to the Tax Foundation, Inc., as associate with the Lincoln Institute of Land Policy, and on the editorial board of *The American Journal of Economics and Sociology*. He is author of *Gift Taxation in the United States* (American Council on Public Affairs), *Money and Banking* (Allyn and Bacon), *American Economy* (Irwin), and *Innovations in Tax Policy, and Other Essays* (University of Hartford Press); co-author of *American Public Finance* (Prentice-Hall); and editor of *Government Spending and Land Values* (University of Wisconsin Press). He is a past president of the National Tax Association.

ROBERT F. HÉBERT (Ph.D., Louisiana State University), is associate professor of economics and a member of the graduate faculty at Auburn University. Co-author of *A History of Economic Theory and Method* (McGraw-Hill), he has published a number of articles in the history of economic thought.

OSCAR B. JOHANNSEN (M.B.A., Ph.D. candidate, New York University), author of pamphlets and articles in economic and political theory, was awarded the grand prize for the best essay on the free enterprise system by the National Association of Manufacturers in 1975. After a long career in industry, he recently retired as secretary to the president of the United States Steel Corporation, to devote himself to doctoral studies in economics, and to service as vice-president of *The American Journal of Economics and Sociology* and contributing editor of *Fragments*.

JACK SCHWARTZMAN (J.S.D., St. Lawrence University; Ph.D., New York University), a native of Russia, has practiced law in this country for more than forty years. In addition, he is professor of English at Nassau Community College, State University of New York. In 1974 he won the New York State Chancellor's Award for Excellence in Teaching, and was subsequently appointed to the committee that recommends the awards. He is author of *Rebels of Individualism* (Exposition) and some three hundred articles, and chairman of the editorial board of the occasional journal *Fragments*.

WILLIAM B. TRUEHART (Ph.D., Claremont Graduate School), a lecturer in economics for the San Diego Community College District, formerly served as

a staff executive with the Lincoln Institute of Land Policy. He is a member of the San Diego County Board of Assessment Appeals, and has written several articles and study guides in economics.

LOUIS WASSERMAN (Ph.D., University of California at Berkeley) is professor emeritus of philosophy and government, San Francisco State University. A past president of the Northern California Political Science Association, he is author of *Modern Political Philosophies* (Garden City—Doubleday; New Home Library) and many articles in political theory, joint author and editor of *American Institutions and Ideals* (Gutenberg), and co-author of *Self-Help Cooperatives in Los Angeles County* (University of California Press).
