THE EDITORS ?

HARRY GUNNISON BROWN was professor of economics at the University of Missouri until his retirement in 1951. He is now a member of the economics department of the University of Mississippi. Among his many published works are The Economic Basis of Tax Reform (1932) and Basic Principles of Economics (1942).

HAROLD S. BUTTENHEIM is editor of *The American City Magazine*, a monthly publication devoted to the betterment of cities, towns and villages. He has held, and still holds, important active or honorary connections with organizations concerned with housing, zoning, city planning, and municipal administration.

PHILIP H. - Hou-Chun Chang, B.S., M.B.A. (Harvard), was formerly a colonel in the Chinese Army. Among other things, since his arrival in this country, he has served as editor of the *Chinese Times*, San Francisco.
- E. J. Craice represented the Flinders District in the Parliament of South Australia from 1930–41. He is a lecturer and writer on land-value taxation and for 37 years has been secretary of the Henry George League of South Australia. He is vice-president of the Henry George Foundation of Australia and was president of the International Union for Land-Value Taxation and Free Trade.
