# Some Places to See in Toronto

Toronto is the seat of government for the Province of Ontario. The Parliament Buildings are located in Queen's Park, adjoining the University of Toronto.

Toronto is unique in the character of its homes for the ordinary citizen. There are tens of thousands of houses, detached or semi-detached, lining the streets of the city proper and suburbs with lawn space in front and garden space behind.

ROYAL ONTARIO MUSEUM, corner Bloor Street West and Avenue Road, has five departments: Archæology, Zoology, Palæontology, Mineralogy and Geology. The museum is said to rank fifth on this continent. Its Chinese collection is one of the finest in the world. Open daily from 10 to 5 and on Sundays from 2 to 5. Delegates to conventions are admitted free of charge in groups and a guide will be assigned to each group.

CASA LOMA, the Show Castle of this Continent, built by Sir Henry Pellatt, a Toronto broker. At today's value of materials the property (23 acres) would be worth \$3,750,000. Taxes jumped from \$400 per year to \$1,000 per month, and Sir Henry had to relinquish his dream castle to the city. The Kiwanis Club of West Toronto, Inc., operates the Castle as a welfare project, paying 25 per cent. of the proceeds to the city as rent, and donating the excess profits to children's work. Casa Loma is open every day including Sunday from 10 a.m. to 9 p.m. Admission: Adults 25c; children 15c on week days, 25c on Sundays. Art Galleries, including a Canadian historical collection, a replica of the Vimy Ridge Memorial, and many other features, are included in the personally-conducted tour.

CANADIAN NATIONAL EXHIBITION, which celebrates this year its Diamond Jubilee, is known as the World's Largest Annual Its beautifully landscaped grounds are a veritable parkland, 350 acres in extent, with a waterfront of 1½ miles. Among its many stately permanent buildings is the world's largest exhibition building, including under one roof an area of 24½ acres. The Exhibition represents an investment in land and buildings of \$21,000,000. The exhibits are international in character, and in addition to representative exhibits from the British Empire, the United States and France, there will be exhibitors from Finland, Czechoslovakia, the Netherlands, Poland, Norway, Italy and Germany. Among the entertainment features is the band of the Royal Artillery from England, which performs twice daily in a new bandshell acknowledged to be the finest in the world. Three dance bands—Benny Goodman's, Tommy Dorsay's and Guy Lombardo and his Royal Canadians—are among the bookings for the new outdoor dance pavilion, said to be the world's largest. There is a grand-stand spectacular performance each evening. The Exhibition will be in progress during the Congress, and is well worth seeing. Admission 25c.

# The Congress Meeting Place
