"Replace the term Free Trade"

Sir, The national markets today are not so heavily dominated by monopolies and privi-leges as they were 100 years ago. Today the idea of Free Trade prevails over the idea of Protection that was dominant a century ago. But the national markets are not functioning as well as they could possibly do, and we still want to abolish the privilege for landowners to withhold for themselves the public created rent of land.

The market outside national jurisdictions today is extremely free, dominated by influential and wealthy international companies who are able to direct their profit to nations that will give them the advantage of low taxes, and to direct their activities to nations that will give them other advantages. The national governments are unable to stop exploitation of differences in law systems and development of societies and they cannot avoid damaging effects of sudden changes in supply and demand

Today nobody is able to regulate international trade, and where some rules have been given by supra-national organizations nobody is able to maintain the power of justice need-

ed to enforce the rules.

This almost absolute freedom for giant international companies means less freedom for producers, traders and consumers in the national societies. During the recent decades it has caused tensions that have led to social unrest and commotion, of which the disturbance in Seattle, November 1999, against the World Trade Organization (WTO) was a serious manifestation.

People don't like the free trade they are witnessing; they want provisos to be taken. Georgists want that kind of Free Trade that Henry George wrote about - most strongly in his book Protection or Free Trade.

The Georgist idea is based on the philosophy that all human beings have equal rights to the gifts of nature and to the values created by generations of citizens in social cooperation, and to the values created by nowadays' public spending.

This idea needs protection against those privileged citizens who want to withhold for themselves the value of the common created advantages that they are able to collect or enjoy from their privileges.

Further, I am convinced, Georgists have always accepted certain regulations of production and trade maintained in order to avoid injuries on health and life of human beings. I am sure also, that Georgists accept restrictions against certain risks of production and exchange of services and goods, including restrictions that shall avoid immoral treatment of animals, and pollution of soil, air, water and - at some locations - noise, and interference of radio waves.

That indicates that the Georgist Free Trade does not mean absolutely free trade.

Today people in general understand Free Trade as complete freedom to act and trade. They don't like Free Trade, and want protection against it. Therefore, today Georgists cannot proclaim that they are struggling for Free Trade without being misunderstood!

We have to find an expression instead of Free Trade. But WHICH?

Some time ago the Guardian published a short sentence saying that there are approximately 5,000,000 sites in the UK the ownership of which are not known and according to the Registry this represents about 30% of the whole.

This, of course, puts a severe con-straint on the introduction of LVT

although new legislation now provides (from 1998) for compulsory registration on a conveyance or a First Legal mort-This will speed things marginally but Georgists could help further by searching their deeds for evidence of such registration and initiating the process if it is called for. I'm a country doctor working in the wilderness of Dartmoor and far removed from the world or high finance. Nevertheless certain facts appear to me to be self evident for anyone to see who is willing to look.

- · Central banks create and issue money a credit.
- Money has to be horrowed into existence In Britain about 3% of the currency is minted and printed by the government as base metal coinage or banknotes, 97% is created and issued as credit by one mech anism or another, by private financial institutions such as banks.

People borrow money believing that it is money on deposit with the lender, money that he is not using and is willing to lend out at interest. People and governments do not realise that credit is created out of thin air and credit becomes legal tender the moment it is borrowed. The borrower creates money by borrowing it. The borrower unwittingly counterfeits money by borrowing money and is a counterfeiter by proxy. But this is no ordinary counterfeit money because Interest has to be paid for its base and it must be returned to the lender as money. The lender of credit will not accept repayment with credit, only with money, which previously didn't exist.

Stated in these stark uncompromising terms we are looking at the biggest scam in human history. But nobody ever says so. It is fraud and I asked the Chief of Police to investigate.

"Dr Hamlyn" he replied, "when fraud becomes government policy it is no longer fraud." How true, but of course government itself then becomes the fraud.
