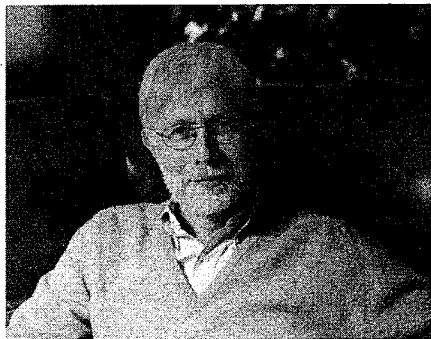

Les Leopold cofounded and directs two nonprofit educational organizations, the Labor Institute and the Public Health Institute, where he designs research and educational programs on occupational safety and health, the environment, and economics.
