## On the Passing of Arthur P. Becker

OUR BELOVED COLLEAGUE, Arthur P. Becker, died suddenly on November 17, 1978. Arthur served for years as a contributor to this Journal and as a member of its editorial board; and he also served with me as a director of the Robert Schalkenbach Foundation, of which he was also director of research. His passing has stricken all of us who knew him with deep grief. A suitable memorial, taking account of his contributions to fiscal economics, will be published in this Journal in due course. Here I wish only to record the sense of loss felt by all who knew and worked with him, both at the University of Wisconsin-Milwaukee (where Dr. Becker was professor of economics), and in New York, Cambridge and other parts of the country, where he had affiliations as researcher or consultant.
