Radical But Not New

"Taxation as a Tool of Urban Planning" was the title of an article by Wesley L. Orr, Professor of Engineering at the University of California, Los Angeles. It appeared in a Boelter Anniversary Volume published by McGraw-Hill in 1964, Heat Transfer, Thermodynamics and Education.

Bruce Michels of Los Angeles called this to our attention. On the subject of slums Professor Orr said he proposes a "neighborhood tax, the rate of taxation being based on the cost of governmental services to that community averaged over a period of two or three years."

He believes the present system penalizes thrift, self respect and ambition. He would levy a tax against each building lot, whether improved or not, "at a rate that would annualize the capital costs of the utilities which are available to that lot." He says his proposal, while radical, is not new since "in a different

form and for different purposes, a somewhat similar suggestion originated in California nearly a hundred years ago by Henry George."

"Slum districts," said the author, "are often mentally associated with old buildings but this association is not necessarily true, some neighborhoods have aged with dignity and charm and are not slums, while some relatively new housing projects have already degenerated into slums. Slums are popularly thought of as localities in which the residents earn low incomes but this, too, is not necessarily so; many low income communities are well kept and respectable. The underlying characteristics of a slum are human in nature and include nuisance creation; disregard for maintenance; high incidence of sickness, disease, and accidents; lack of sanitation; many fires; low level of achievement ambition; moral degradation; and high incidence of juvenile and adult delinquency."
