INTERNATIONAL CENTENARY CONFERENCE IN NEW YORK CITY

Hotel Commodore, August 30th to September 2nd, 1939

SUMMARY OF PROGRAMME

THE CONFERENCE will open with an address of welcome by a representative of the City of New York to which responses will be made by Mr Bue Björner, President of the International Union for Land Value Taxation and Free Trade, Mrs Anna George de Mille, President of the Board of Regents of the Henry George School of Social Science and Mr George E. Evans, President of the Henry George Foundation of America.

The printed papers of which a list is given on this page will be presented in convenient groups at various sessions of the Conference, being briefly introduced either by the authors or by some delegate on behalf of the author.

In addition to the printed papers, addresses will be delivered by the Hon Lawson Purdy, President of the Robert Schalkenbach Foundation, Mr Clarence B. Streit, author of *Union Now*, Professor Hiram B. Jome of Depauw University on "A Lesson in Continuity," Rabbi Michael Aaronsohn on "Farewell to Magic," Mr Walter Fairchild on "The Beauty and Blight of a Great City," Mr H. B. Cowan on "Georgeist Approach to Business," Mr Gilbert M. Tucker of the Tax Relief Association, and Mr Nathan Hillman of the Henry George Fellowship.

Among those taking the Chair at the various sessions will be Messrs DeWitt Bell, Leon T. Arpin, M. B. Thomson, Ezra Cohen, Reginald Zalles, Michael, J. Bernstein and George Green.

The final evening session will take the form of a Banquet (at the Hotel Commodore) presided over by Mr C. O. Steele, at which the speakers will be the Hon Francis Neilson, the Hon Peter Witt, and Mr Jakob E. Lange of Denmark.

Next day, 2nd September, the centenary date, the Conference meets at Luncheon in the "Casino of Nations," at the World's Fair, Mr B. J. Hoffman presiding. The speakers will include Judge Samuel Seabury and Mr Richard R. Stokes, M.P.

Arrangements are being made for the Conference to have radio time every night and the Saturday afternoon addresses at the Luncheon will probably be broadcast entire. Moreover, it is expected that prominent Conference members from Europe and Australia will give special talks on the radio during their stay in New York.

Attending from Europe are Mr Bue Björner, President of the International Union, Mrs Caroline Björner, Mr Jakob E. Lange and Mr Morten Lange from Denmark; Mr F. C. R. Douglas, M.A., Mr George Green, Mr Ashley Mitchell and Mr R. R. Stokes, from Great Britain and N. Ireland.

Mr Douglas and Mr Stokes will be present at the Centenary Celebration in Montreal on September 7th.

NATIONAL CONFERENCE IN LIVERPOOL

Picton Hall on 30th September

The United Committee, in association with the Liverpool League for the Taxation of Land Values, have decided to convene a National Conference on the Taxation and Rating of Land Values which will be held in the Picton Hall, Liverpool, on Saturday, 30th September. In conjunction with this Conference there will be a Henry George Week-end Conference in the Victoria Hotel, Southport, 1st October.

The National Conference will consist of two sessions, the first in the afternoon and the second in the evening.

The afternoon session will be devoted to the rating of land values and the municipal demand for the necessary legislation.

The evening session will be devoted to Land Value Taxation in relation to employment, the abolition of tariffs and international peace.

At each session a resolution will be submitted for the consideration and approval of the Conference.

To the afternoon session delegates will be invited from local authorities, municipal organisations and ratepayers' associations all over the country, and to each session delegates will be invited from many political

each session delegates will be invited from many political and economic bodies, including Labour and Liberal parties, Co-operative Societies and Guilds, Trade Unions, etc., etc.

Full particulars will be announced next month.

Visitors' tickets will be available for everyone interested, in addition to those who will be present as delegates representing this or that authority, association or corporate body.

Our readers are also cordially invited to the Week-end Conference in the Victoria Hotel, Southport. This will take the form of the Conferences recently held at Matlock Bath where the time will be devoted to matters of importance affecting the progress of the movement, the educational work of the Henry George School of Social Science, the dissemination of the literature of the movement, and other subjects.

Mr D. J. J. The pamphlet came out of Mr Owen's address at the Matlock Bath Conference, May, 1938, proving that conferences, however modest, can have results beyond all expectations. Congratulations to D.J.J.O.
